Application Process

- a. NPCA will request grades, test scores, and disciplinary records from the student applicant’s current, or most recent school
- b. Home School Reports and/or any standardized testing completed in a home school environment or other micro school should be provided with the application
- c. Immunization records should be provided with the application, if available at the time of submission, or otherwise **MUST** be submitted to the school office no later than the first day of school.
- d. A non-refundable \$100.00 registration fee must be submitted with this Student Application form. Checks should be made payable to North Pointe Christian Academy with a memo of “NPCA Registration Fee.”
- e. Applications will be reviewed by the Board of Directors.
- f. Parent(s)/Guardian(s) will be contacted for an appointment for a student evaluation and interview.
- g. If accepted, enrollment requires a Curriculum Fee of \$400 that must be paid no later than June 1, 2022 to ensure that the student’s supplies are available and ready for the first day of school.
- h. Student’s will be expected to adhere to the Uniform Policy, which will be provided upon acceptance.
- i. The start of the NPCA School year for 2022-2023 will be Monday, August 22, 2022. A full school calendar will be provided.
- j. Additional paperwork requirements with due dates will be provided upon acceptance.
